

BID FOR A SUITABLE SERVICE PROVIDER TO DO SPLICING OF FIBRE OPTIC CABLE

1. PURPOSE

The purpose of this bid is to appointment a suitable service provider to splice Fibre Optic Cable.

2. BACKGROUND AND OBJECTIVE

Senqu Municipality has a number of buildings in Lady Grey. Offices in these buildings are currently connected to the Senqu Network in various ways which in some cases are unstable. These connections are being replaced by Fibre Optic connections.

3. SCOPE OF WORK AND KEY DELIVERABLES

Offices that need to be linked are:

- Main Office Server Room to Fleet Bay
- Main Office Server Room to new Server Room (in the currently being renovated DTPS/Community Services building)
- New Server Room to Technical side of the building
- New Server Room to Offsite Backup
- New Server Room to Tourism Office

Please note that the installation of the cable from pole to pole between the buildings and from the last pole to the point where the splicing needs to take place will be done by Senqu Municipality. It is only the fusion splicing that needs to be done by the service provider.

A total of 80 X Fusion splices need to be done on single mode short span cable. Accommodation, transport and any other overheads must be covered in the quote.

4. PRE- ASSESSMENT CRITERIA

The Service provider is expected to be experienced in fusion splicing.

Please supply copies of **5 Reference Letters** from various institutions, with contactable details, as proof of experience. The quote will not be accepted if this is not provided.
