BACKGROUND

Abantu Environmental Services was appointed by Senqu Local Municipality (SLM) to develop an Environmental Management Framework (EMF), specifically an Environmental Management Plan (EMP) as per the requirements of the National Environmental Management Act (107 of 1998). The purpose of the Plan is to provide the municipality with a comprehensive picture of the status of the environment and give strategic direction and structure for addressing environmental problems, and identify opportunities concerning environmental matters, especially related to natural resources management. The EMP must be endorsed by the Department of Economic Development, Environmental Affairs and Tourism (DEDEAT), thereafter approved by the Senqu Municipal Council and thereafter incorporated into the municipal Integrated Development Plan (IDP).

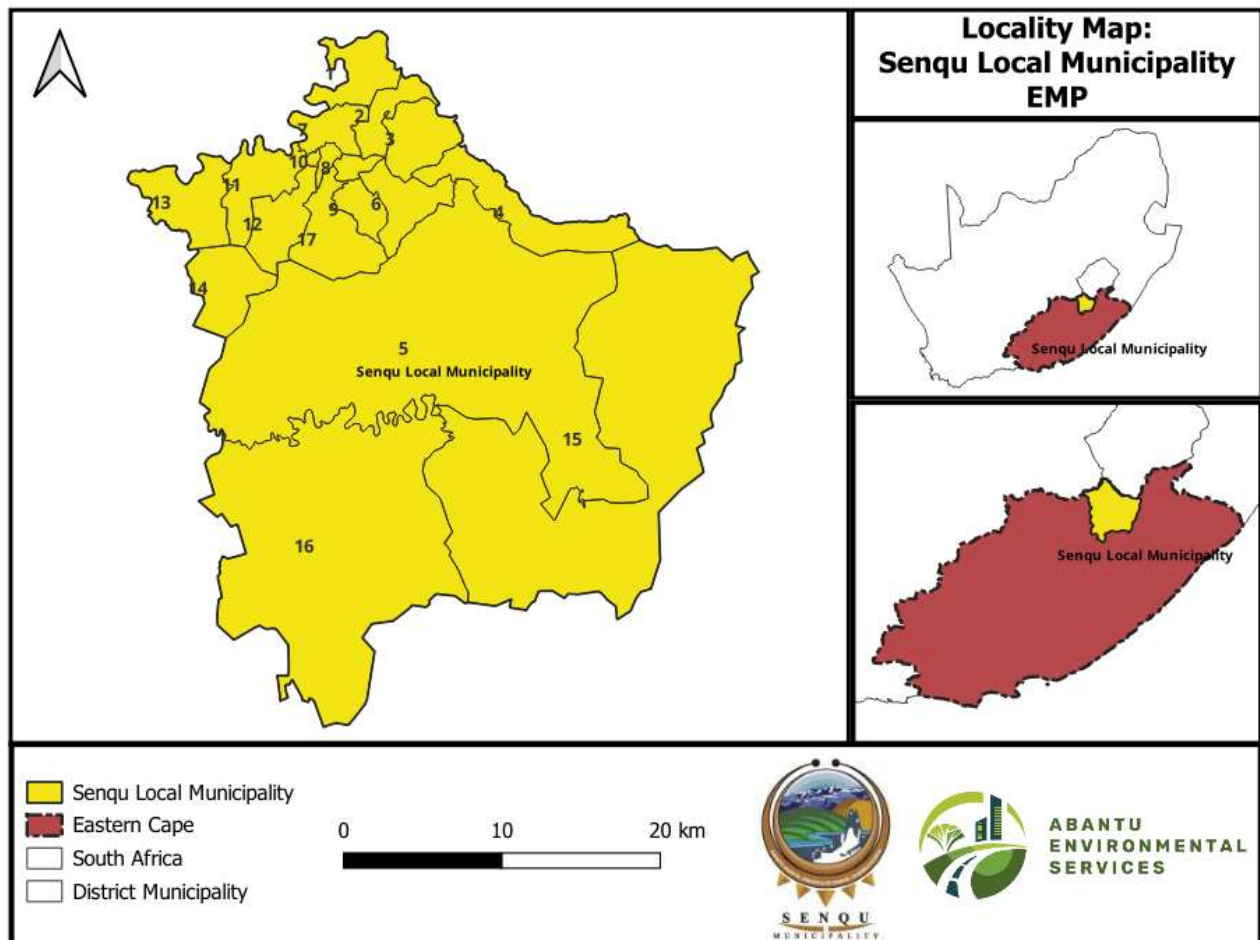


Figure 1. Locality map of Senqu Local Municipality
